FAMILY EDUCATIONAL RIGHTS AND PRIVACY ACT (FERPA) NOTICE FOR RELEASE OF DIRECTORY INFORMATION

The Family Educational Rights and Privacy Act (FERPA) is a federal law that protects the privacy of student education records. Summerville Union High School District, with certain exceptions, must obtain your written consent before releasing your student's education records or directory information to third parties.

This form allows you to:

- Authorize or restrict the release of your student's directory information.
- Opt in or out of sharing student data with the California College Guidance Initiative (CCGI).
- Control access to academic records such as transcripts, grades, class schedules, and enrollment status.

Directory Information Release

Summerville Union High School District may share student directory information (name, address, phone number, honors/awards, participation in activities/sports) with:

- Yearbooks & Honor Roll Publications
- Local Newspapers & Graduation Vendors
- Scholarship Organizations & Colleges
- Sober Graduation Committee & Summerville HS Foundation

California College Guidance Initiative (CCGI) Participation

The California College Guidance Initiative (CCGI) helps students explore college and career options while streamlining the college application process. Through CCGI, students can track their academic progress, explore financial aid, and send verified transcripts directly to participating colleges.

Military Recruiter & Armed Services Opt-Out (Per Federal Law)
