Bids are required for the entire project as set forth in the Bid Documents and must be submitted on the provided forms. Bid must be accompanied by cashier's check, certified check or bidder's bond 10% of the base bid. The successful bidder will be required to furnish performance and payment bonds 100% of the contract price. All work shall be completed on weekdays, no holidays and during hours when school is not in session between June 10<sup>th</sup>, 2019 to August 9<sup>th</sup>, 2019. At the time the contract is awarded, the contractor shall possess a **C-10 Electrical Contractor** license or appropriate state of California licensing for the work required. Any bidder not licensed or registered with DIR as Public Work certified at the time of the bid opening, or does not meet bid requirements will be rejected as nonresponsive. The board reserves the right to reject any and all bids. The Board also reserves the right to waive any informality in any bid received. The successful bidder will be selected per the lowest base bid. This project is "public work" to which general prevailing wage rates will apply. Contractor will pay prevailing rate of per diem wages for the type of work performed and the locality in

which the work is to be performed within the boundaries of the School District. Certified Payroll Reports will be requested.

**PROJECT DETAILS:** This is a lighting upgrade project under Proposition 39. Lighting upgrades will include the retrofit of exterior fixtures to LED lamps and a retrofit of the bus barn florescent strip lighting to new LED fixtures. Contractor will remove, dispose of old equipment and materials to install new lighting, and will provide all equipment and labor to complete the project. Contractor will be responsible to verify project counts and equipment, verify all project equipment and labor needs and confirm understanding of all project aspects during the mandatory walkthrough.
